- The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate appendix III issued by District Education Officer (DEO) /equivalent officer
- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable p 4. in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas. The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there of for refere
- purpose and also advised to visit CBSE websites i.e. http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates. The School 5. expected to see all circulars on these CBSE websites regularly.
- The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Further, will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys 6. girls separately in proportion to the number of students. The school will ensure that Fire, Building, health and sanitation and s drinking water certificates are renewed from time to time, as per norms.
- Admission to the school is to be restricted as per relevant rules of Examination Bye-laws and rule 2.4.5, 2.6.5, 7.1, 7.2, 8.4 8.4.10 & other relevant rules of Affiliation bye laws.

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjections. 13. school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations fi the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing we 14 time about the non-sponsoring of the candidates.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examina 15. is not permitted by the Board. Strict action would be taken on defaulters.
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ 16. 17.
